Agenda for this meeting and year.

1. Alternate repeater - This is a replacement to try for our former 440. We share our 2 meter 147.00 repeater with other clubs for nets or public service, and with the "public" on a daily basis. As a result, many Members feel that our 2 meter repeater is not suitable for them to the extent that 440 was. The suggestion to use Skipp's 900 MHz repeater is still in effect, but has not produced results, despite increased use of the band. W6YDD now has a third repeater on 146.625 on Vaca. It is open and if our members don't use it any more than they claim they like to hear, we would be welcome. This invitation is coordinated. Let's try it until at least the April meeting to see if it is acceptable to us and the repeater owners. Although this is an open repeater, this invitation is specifically for MVRC Members and Sponsors. Read the separate article about W6YDD 146.625 before using it.

2. Public Service - We continue to list Public Service in our Activities when we have or might take part. But it is up to individual members to sign-up.

3. Mobile Runs - We used to have these (Sunday Drives, Caravans) occasionally but haven't recently. If there is interest at the January meeting, I propose an interesting industrial tour in Western Placer County, close to home for many of us, in March.

4. Camping - We need to start working on one or more simple campouts during 2013. When we plan and announce Ham campouts, people come. Yet everyone sits on their hands at meetings. Please come to the January meeting prepared to take action.

5. HF Net - The Saturday night 75 meter net is an interesting experiment using HF for a change. It has been in operation almost

8. Repeater - We need to complete moving our Echo-IRLP nodes to the 147.00 repeater on Mt. Vaca from a member's QTH. Some Members and Sponsors express a need for it. Also, we could have GMRS back on, but I have no indication that any Member depends on it.



W6YDD, a "club" call, is known for 1.2 and 440 repeaters, and was associated with the former WB4YJT Grass Valley and Bald Mt (Georgetown) repeaters on 146.625(-), which are now W6YDD. The Bald Mt repeater is used for several public service activities that MVRC members assist. Recently, a W6YDD repeater on this frequency was added to Mt Vaca with a third PL tone. When using any of the three, let the carrier drop, they are not linked. Coverage overlaps in our area, but Vaca would be our primary. Here are the three tones.
Tone One - Grass Valley - 151.4
Tone Two - Bald Mt - 123.0
Tone Three - Mt Vaca - 94.8

Operating Guide for Repeater usage

The MVRC repeaters are equipped with 30 second timers in response to the membership's desire that transmissions be short, direct and to the point like face-to-face conversations. The MVRC system is a large party line that should be kept open for use by as many users as possible. When entering a conversation in progress, identify using your **call sign** only. The use of the word BREAK is discouraged. Give your call sign in the time period between when one member of the conversation stops transmitting and the courtesy tone occurs.

When the system is being used for Public Service please give that traffic priority. All Amateurs are welcome to use the open repeaters and in open contacts which do not impede the use by others.
